

EARLY VOTING OPERATIONS

After-Action Report November 2022 General

Submitted - December 20, 2022

This narrative is provided to the Election Integrity Commission and Board of Supervisors reviewing the Pima County Recorder's Office administration of Early Voting operations for the 2022 General Election.

EARLY VOTING OPERATIONS OVERVIEW

For the 2022 General Election, there were 639,885 active voters in Pima County. Of those active voters, 480,321 were on the Active Early Voters List (AEVL) and were automatically sent an early ballot by mail.

Additionally, there were 65,187 inactive voters eligible to participate in the election. An inactive voter is someone who needs to update their voter registration information. The inactivation occurs when our office has cannot confirm a voter's current address because we have received two pieces of returned mail. After two federal election cycles, if an inactive voter has not contacted our office or updated their voter registration information they are cancelled and removed from the voter roll. A voter can re-activate their registration by contacting the Recorder's Office, updating their voter registration, or signing a petition. Because inactive voters are still eligible to vote, if they show up to an early voting site or a vote center on election day, they can re-active their status at that time too.

By the October 11 voter registration cut-off date, there were 705,072 total voters eligible to vote in the General Election.

The Recorder's Office entered an active election period on September 24 when we mailed **1,807 Uniformed and Oversees Citizens Absentee Voting Act (UOCAVA) ballots** to Military or Overseas Voters.

The Early Voting period started on October 12 and ended on November 4. Emergency voting was available to any Pima County voter on Saturday, November 5 and Monday, November 7.

During the Early Voting Period, the Pima County Recorder's Office mailed a total of 507,473 early ballots to voters. 480,321 AEVL voters automictically received a mail ballot. 27,152 voters, who were not on AEVL, requested an early ballot by mail.

Voters returned by mail 236,616 early ballot packets between October 17 through November 8. During the Early Voting Period, 42,507 early ballots were dropped off at early voting locations. Also, 9,094 total early site ballots were issued. Our Team Voting Boards helped 29 housebound or ill voters cast a ballot for the 2022 General Election.

Voters returned a total of 332,318 early ballots to our office. Voter staff rejected 970 returned early ballots for various reasons. The Ballot Processing Center successfully signature verified 331,348 early ballots. However, 44 ballots were redlined because the Elections Department Early Boards found something other than a valid 2022 General Election ballot inside the affidavit envelope.

The Elections Department received a total of **331,304 returned early ballots for tabulation**. (See attached Early Ballots Processed Summary and other supplemental reports for additional details regarding the total number of ballots verified for tabulation.)

On November 9, the Pima County Elections Department delivered 44,102 returned early ballots (late earlies) dropped-off at Vote Centers on Election Day. The Elections Department also delivered 2,460 provisional ballots and 70 conditional provisional ballots. However, the Ballot Processing Center staff determined there were actually 2,493 provisional ballots and 68 conditional provisional ballots.

Staff successfully verified 1,838 provisional ballots and 19 conditional provisional ballots, totaling 1,857 verified provisional and conditional ballots for tabulation.

BALLOT DROP-OFF LOCATIONS / EARLY VOTING SITES:

The Recorder's Office operated 15 Ballot Drop-Off Locations / Early Voting Sites (EVS) in Pima County from October 12, 2022, through November 7, 2022. Three locations were open from October 12 through November 4. One location was open from October 24 through

November 4. And 11 sites were open from October 31 through November 4. Emergency voting was available at 11 locations on November 5 and 7 to any eligible Pima County voter.

When planning the total number of Early Voting Sites (EVS) and the dates to open them, we examine the turnout history for each site. With a certain degree of accuracy, staff can determine how busy a site will be during the election. With this analysis, we can create a staggered opening schedule to accommodate the anticipated voter volume in certain areas. Also, staff work to ensure Emergency Voting locations are open and accessible to voters across Pima County and located relatively close to where they live.

During the 2022 General Election, some Early Voting Sites (EVS) experienced unprecedented turnout. The EVSs issued a total of 9,094 site ballots, with the Eastside Replacement location (Fellowship Bible Church), the Oro Valley Public Library, and our downtown office issuing the most ballots overall. Early voting sites were supported with four designated site monitors during the General Election to cover expanded call volume due to increased voter turnout at the sites.

STAFFING:

The Recorder's Office increased staffing in all areas for the General Election to alleviate any issues with party balance at Early Voting Sites. The Ballot Processing Center staff also increased during this election with more staff dedicated to ballot processing, courier teams, and team voting.

Early Voting Election Staffing Overview:

- 24 Permanent Recording & Voter Registration Staff assigned to various election operations.
- 137 Intermittent Employees assigned to various election operations including:
 - Ballot Processing
 - Signature Verification
 - Problem Ballot Processing
 - Team Voting
 - Site Couriers
 - Early Voting Sites
 - Phone Coverage

EARLY VOTING ELECTION WORKER TRAINING:

The accountability structure of Early Voting Sites was completely overhauled during the 2022 Election Cycle. To provide voters with an Early Voting experience that is secure, consistent, and accurately administered, the Recorder's Office provided a more robust support structure for the site workers. The Recorder's Office continued to build on the revised training materials and site procedures from the Primary Election and included additional revisions for the 2022 General based on staff and community feedback to support staff and voters using visiting an Early Voting Site.

The Recorder's Office continued to conduct multi-day trainings for each task in advance of the job assignment to ensure staff were fully comfortable with the processes and procedures expected.

The following training was provided to intermittent staff and permanent staff assigned to various election operations:

- 4 Early Voting Site Worker Trainings
 - Three full trainings that consisted of
 - One day with processes, laws, and equipment introduction.
 - Half day with new Accessibility Module and hands-on equipment / technology training.
 - One half day training for late hires assigned to EVS
- 1 Signature Verification Process Training
- 1 Problem Ballot Process Training
- 1 Ballot Processing Training
 - Included Courier & Ballot Chain of Custody Training
- One Provisional Ballot training.
- 1. Each site had a designated Site Captain who was either a permanent staff member or a more experienced site worker. Site Captains were responsible for more of the decision making and reporting at Early Voting Sites.
- 2. Throughout the Early Voting period, three or more Site Monitors were available at our Downtown location to troubleshoot equipment issues, help make decisions, and report any issues to the Recorder's Administration. This relieved site workers of making decisions outside of ordinary site operations.

VOTER OUTREACH & ELECTION COMMUNICATION:

The Recorder's Office enhanced the "Track My Ballot" feature on the department's website allowing voters to sign-up for text message notifications reporting the status of their returned early ballot at every stage of processing.

Staff answered 27,809 voter phone calls between September 26 and November 8. Also, the office responded to 174 email inquiries regarding early voting and other election related questions.

BALLOT COURIER OPERATIONS:

From October 17 to November 8, the Ballot Courier teams picked up 236,616 mailed ballots from the Cherrybell Post Office. Additionally, courier teams picked up a total of 41,272 returned early mail ballots from EVS locations county wide between October 17 and November 7. On November 8, 1,235 voters dropped off their early mail ballot at our Downtown Office and Country Club Ballot Processing Center. A total of **42,507 early mailed ballots were dropped off** by Pima County Voters to one of our locations.

"PROBLEM BALLOT" - EARLY BALLOT CURE PROCESSING:

During every election, some returned early ballots will be flagged for additional follow-up. Internally, the team that deals with these special situation ballots is known as the Problem Ballot Team. This specialized team worked with voters to resolve any issues identified so their ballot was counted for the 2022 General Election.

The Problem Ballot Team helped 1,157 voters cure their ballots. Staff contacted voters by mailing letters, calling, and texting to notifying them that they needed to resolve an issue with their early ballot before it was submitted for counting.

The Pima County Recorder's Office also participated in the AZ Secretary of State's "TEXT 2 CURE" program, which provided voters another avenue to contact our office to cure their ballot. 154 Pima County voters used this option to ensure their early ballot was counted. An additional 150 ballots were approved by a supervisor and 8 ballots were re-assigned due to household mix-ups.

Overall, the Problem Ballot Team *resolved 1,469 early ballot issues* before the November 16 cure deadline. (See attached report for additional detail.)

PROVISIONAL BALLOT PROCESSING:

Because of SB 1460's passage this year, as well as the use of e-poll books, the number of provisional ballots issued at vote centers were greatly reduced. 18,631 voters who were issued an early mail ballot, but did not vote it, showed up to vote in person at a vote center. Those voters were issued a regular ballot by the poll workers rather than a provisional ballot as would have been standard in prior elections.

During the November 8 General Election, vote centers issued a total of 2,493 provisional ballots and 68 conditional provisional ballots. Recorder's Office staff successfully verified 1,838 provisional ballots and 19 conditional provisional ballots eligible for tabulation. (See

attached report for provisional issue reason and conclusion of the provisional ballot detailed report.)

ELECTION OBSERVERS:

From October 17 through November 14, political observers from both major political parties sent observers to review the signature verification process at the Ballot Processing Center.

- The Pima County Republican Party sent 41 observers spending about 110.5 hours total watching the ballot processing center's operations. Republican observers averaged 4 hours per visit.
- The Pima County Democratic Party sent 21 observers and spent about 55.75 hours total at the facility, with an average of 1.5 hours per visit.

NON-POLITICAL PARTY OBSERVERS:

The Ballot Processing Center also hosted two Congressional observers and two international election integrity observers during the early voting period. These observers were given the same information as the political party observers and allowed to watch the operations of the ballot processing staff from early ballot receipt to final turnover to the Elections Department for tabulation. Unlike the Primary Election we did not have unaffiliated "election observers" attempt to enter the Early Voting Sites.

BALLOT DROP BOXES:

Pima County does not currently use unstaffed Early Ballot Drop-Off Boxes.

ELECTION WORKER PHYSICAL SAFETY:

Physical safety continued to be a concern for staff at our Early Voting Sites and the Ballot Processing Center. Our office continued to use VetSec security at critical locations. Administrative staff also worked closely local law enforcement partners to report suspicious behavior, threating or menacing email or phone messages. During the Early Voting Period through the Election Day and after, our staff received several aggressive phone calls from individuals regarding election operations. All negative and aggressive contact with our office was reported to the appropriate law enforcement partners.

PUBLIC COMMENTS / CONCERNS REGARDING VOTING:

The Recorder's Office received predominately positive feedback from the voting public related to the early voting operations. We saw many positive comments on social media about the professionalism of our staff, the uniqueness of our stickers, the ease of voting, the improvements on our website and the tracking feature on our website. We also received several pleasant phone calls, and website comments, highlighting the professionalism and dedication of individual staff members and praising their knowledge and customer service.

However, we continue to see a rise in angry, abusive phone calls from callers who are repeating the anti-voting rhetoric that we've seen across the country. Operators have been instructed to give a warning that inappropriate language will result in terminating the phone call. Phone calls, emails or social media comments that physically threaten our staff or office will be forwarded to local law enforcement as per our safety protocols.

The abusive phone calls take a mental and emotional toll on our staff. We will be designing additional trainings to provide more support to operators to better deescalate these types of phone calls.

FUTURE OPERATIONAL IMPROVEMENTS FOR 2024 ELECTION CYCLE:

Our office is conducting an in-depth debrief regarding the 2022 election cycle to identify areas for improvement. We want to expand on our successes and continue to revise internal processes to create workflow efficiencies.

Improvement Ideas Include:

- New info graphics related to Early Voting
- Increased automation during ballot processing phase
- Increased number of early voting sites in rural and outlying areas
- Additional voter education resources on the Recorder's website
- Increased use of text messaging platform for voter notification
- Expanded voter registration trainings with voter engagement groups
- New reference guides for election workers

Early voting is extremely popular with Pima County residents, and we expect the total number of returned early ballots to increase during the 2024 election cycle. Therefore, the Recorder's Office is investigating funding opportunities from state and federal sources to purchase additional equipment used for early voting operations. We are also increasing our total number of permanent voter staff to manage early voting operations more effectively in the next cycle.

CONCLUSION

Early Voting during the November 8, 2022, General Election was very successful. The Recorder's Office staff continued to show dedicated service and professionalism during this election. Their commitment to the voters of Pima County was extraordinary and the success of the Early Voting period is due solely to the hard work of staff.

Our team is continually working to innovate our operations to ensure the meet the challenges of a presidential election year, while also ensuring accessibility for all Pima County Voters. The Recorder's Office commitment to ensuring transparent, efficient, and fair elections we are excited for the 2024 election cycle.
