Friday, June 8th Update of Ballots Returned For the Special CD 8 Election

Pima County Recorder, F. Ann Rodriguez reported today that ballots for the Special Congressional District 8 General Election continue to be returned and processed. Updated numbers shown below are as of 3:30 pm Friday, June 8th.

Out of **328,495** registered voters in Congressional District 8, **190,334** vote-by mail ballots have been mailed out to voters in Pima County thus far, a participation rate of more than **58**% of the eligible voters. **126,409** voters have returned their vote-by-mail ballots so far. Therefore, there are still **63,498** vote-by-mail ballots outstanding. This brings the total percentage returned of those vote-by-mail ballots that were mailed to voters to **66**%. The breakdown by party is shown below as to those ballots that have been signature verified and will be processed to be counted.

This means that the overall turn out as of today for those registered voters who are eligible to vote in the CD 8 Election is now 38% have already cast their ballot. Each day we continue processing the signature verification of ballots that we receive. As of the end of the day today, we have finished processing 127,528 ballots, including walk in early voters.

The deadline for any voter to return an early ballot is 7:00 p.m. on Election Day, June 12, 2012. Friday June 8th was the last day we suggested to place your vote-by-mail ballot in the United States Postal System. If a voter is still in possession of their early ballot, we recommend that they not return it through the mail system since mail processing procedures may result in it arriving too late to be counted. However, there are many ways the voter can still return their early ballot.

If a voter wants to deliver their voted ballot directly to the Recorder's Office, they should take it to any of the Recorder's Office locations.
