MVD database oversight may impact Voter Registrations

A technical oversight in how the Arizona Motor Vehicle Division database interfaces with the statewide voter registration database may affect a select group of voters in Pima County and their Documented Proof of Citizenship.

The Pima County Recorder's Office is working with the other counties and the Arizona Secretary of State's Office (SOS) to find a solution to this issue as soon as possible. At this time, changes have been made to MVD to remedy the issue moving forward. We are waiting on the list of impacted voters from the SOS and once we receive that, we will contact them directly with further instructions, and all relevant information will be posted at recorder.pima.gov.

Officials discovered that due to a coding oversight, some long-term Arizonans who registered under less strict rules did not meet the new standards.

Please note: A lawsuit has been filed that may impact how these voter registration records are handled. Information is quickly changing. Please visit the AZSOS.Gov website for updated statewide information.

Who is affected?

If you meet the following criteria, your voter registration may be affected:

- You received a driver's license before October 1996, AND
- You obtained a replacement driver's license, AND
- You registered to vote in Pima County after January 24, 2005

Who is NOT affected?

- Voters who obtained their Arizona Driver's License after October 1, 1996
- Voters who registered to vote in Pima County on or before January 24, 2005
- Voters who have not moved counties since registering to vote after January 24, 2005
- Voters who possess Arizona Real IDs or "travel" IDs
- Voters who provided acceptable forms of Documentary Proof of Citizenship other than the Arizona Driver's License directly to our office

NOTE: This issue **only** affects voters who meet the criteria mentioned above. If you are unsure about your registration status or have questions, visit our website or contact us directly.
