

# PUBLIC SERVICE ANNOUNCEMENT Attention Voters: Primary Election - Tuesday, July 30, 2024 Check your voter registration!

The Primary Election on July 30 is underway! Ballots to Military and Overseas Voters were sent on June 14, marking the beginning of an active election cycle.

The Pima County Recorder's Office recommends that every voter <u>check their voter registration</u> to ensure that it's accurate and up to date before any election.

All registered voters in Pima County are eligible to vote in the Primary, including voters registered as Independent or No Party Designated.

## Registration

New voters or voters who need to make changes to their legal name, address, party affiliation or the way that they receive their ballot should submit a new voter registration form. Voters with an Arizona Driver's License or State ID can register or update their voter registration online at <u>servicearizona.com</u>.

Paper registration forms are available at any Pima County Public Library, post offices, city and town halls, political party headquarters or any of the Recorder's Offices. Locations of voter forms can be found on our website.

The Pima County Recorder's Downtown Office at 240 N Stone will be open until 10 p.m. on Monday, July 1 for voters to register in person. Submitted forms must be postmarked or submitted online by 11:59 p.m. on Monday, July 1.

# Eligibility

To be eligible to participate, voters must:

- Reside in Pima County at least 29 days before the General Election
- Be a United States Citizen
- Be at least 18 on Election Day
- Have their rights restored if they are convicted felons
- Not been adjudicated an incapacitated person

Military and Overseas voters can register and request a ballot until 7 p.m. on Election Day, Tuesday, July 30. The voted ballot and ballot affidavit must be received by the Pima County Recorder's Office by 7 p.m., Tucson time to be an eligible ballot.

#### Ballots

Voters registered with a recognized political party who are on the Active Early Voting List (AEVL) will automatically be sent ballots starting Wednesday, July 3.

Voters will be sent party-specific ballots. Independent/No Party Designated voters can request either the Democratic or Republican ballot. Voters registered as No Labels who live in a city/town having a non-partisan election will receive only a ballot with the non-partisan races. No Labels registered voters who do not have a jurisdictional election in their area will receive a blank ballot.

Here's what voters can expect on their Primary ballots:

Federal, State and County Offices, Justices of the Peace/Constables, Precinct Committeemen. Marana voters will also see mayor and town council candidates. Oro Valley, Sahuarita and South Tucson voters will vote on town council candidates as well.

The November 5 General Election ballot will include Federal candidates, including the President and Vice-President of the United States, Senate, Congress; State and County Offices; Justices of the Peace/Constables; federal judges; fire/water/health districts; community college and school boards; and statewide and local initiatives. The Pima County Elections Department will finalize the ballot in early September.

## **Early Voting**

Early Ballots will be mailed starting Wednesday, July 3, and in-person Early Voting will begin on that date. Early Voting Sites in Pima County are open from July 3 through July 26. The times, dates and locations are available at <u>recorder.pima.gov/earlyvotingsites</u>. On Thursday, July 4, The Recorder's Office will be closed, and no voting services will be available at any site in observance of the federal holiday. Our office must receive ballots by 7 p.m. on Election Day, Tuesday, July 30. We recommend they be mailed back no later than July 23. They can also be dropped off at any Early Voting Site or on Election Day at any Vote Center.

Voters can request a one-time Early Ballot via our website or by calling the Recorder's Office at (520)-724-4330. The deadline to request a ballot is July 19. They can also request a ballot to be sent to a temporary location via the online form at <u>recorder.pima.gov/BallotByMail</u> and select "I would like my ballot sent to a different address."

We can also send ballots anywhere in the world under the Uniformed and Overseas Citizens Absentee Voting Act (UOCAVA). Overseas and military voters can see whether they qualify and request a ballot at recorder.pima.gov/MilitaryOverseasVoterInfo.
