# What Voters Need to Know for the November 4 General Consolidated City of Tucson/School District Election

The City of Tucson and three Pima County school districts are consolidating their elections on a single ballot this fall in an all-mail election. Typically, the City of Tucson conducts its own elections and school district elections are facilitated by the Pima County Recorder's Office separately. However, to reduce voter confusion, the City of Tucson and County Superintendent's Office have jointly decided to combine their ballot items. The Pima County Recorder's Office will act as a vendor for both and administer the combined all vote-by-mail election.

## Eligibility

This consolidated election is an all-mail election, meaning that every eligible voter within the boundaries of the City of Tucson and the boundaries of the Tucson Unified, Flowing Wells Unified and Sunnyside Unified school districts will be mailed a ballot.

The Recorder's Office will mail ballots to all eligible voters beginning on October 8. Additionally, the Recorder's Office will operate Early Voting Ballot Replacement Sites and Ballot Drop-off locations.

Voters can check whether they are eligible via the Recorder's Office Voter Dashboard.

## **Important Dates**

Ballots for Military and Overseas Voters were mailed on September 19. Voters who qualify for the Uniformed and Overseas Citizens Absentee Voting Act (UOCAVA), have until 7 pm on Election Day to register and request a ballot. UOCAVA voters can also vote via the state's Online Ballot Portal.

For all other voters, the last day to register is Monday, October 6. Ballots will be mailed to every eligible voter on Wednesday, October 8. Replacement Ballots may be requested through Friday, October 24, via in-person voting, visiting the <u>Voter Dashboard</u> to request a ballot, or by calling our Voter Line at (520) 724-4330.

## Early Voting, Ballot Replacement and Ballot Drop Off sites

Voters may vote in person or drop off ballots at four Ballot Replacement and Drop-Off Sites from 8 am to 5 pm, Wednesday, October 8, through Monday November 3.

Thirteen Ballot Replacement Sites will be open on Election Day, Tuesday, November 4, from 6 am to 7 pm. Voters are encouraged to confirm locations, as their regular voting location may have changed.

#### New 24/7 Ballot Drop Box locations

Three secure Ballot Drop Boxes will be open 24 hours, seven days a week from 8 am on October 8 through 7 pm on November 4. This provides voters with a secure and convenient way to return ballots at any time.

Household members, family or caregivers are allowed to drop off ballots other than their own. Those ballots must be in a Ballot Affidavit Envelope signed by the voter.
