## PUBLIC SERVICE ANNOUNCEMENT

Attention Voters - CD7 Special General Election - Tuesday, September 23, 2025  
Election Day falls on Rosh Hashanah so those who celebrate have options!

Pima County Recorder Gabriella Cázares-Kelly would like to share valuable information about the Congressional District 7 Special General Election. Some eligible CD7 registered voters who observe Rosh Hashanah may find it difficult to vote in person on Election Day. The information below will help voters create a voting plan to be sure they can cast their ballots. Early Voting has gained popularity in the past 10 years, with more than 85 percent of ballots cast for the 2024 General Election having been cast early.

### Where and when can I vote?

- Vote early in person at one of our [Early Voting Sites](#) through September 19.
- Take advantage of in-person Emergency Voting on September 20 and 22. You will have to sign an affidavit that you are unable to vote on Election Day, as is required for [Emergency Voting](#) (A.R.S. § 16-411) however, you will not be asked to explain your emergency.
- Request a one-time mail ballot by September 12 via our [Voter Dashboard](#) or by calling the Recorder's Office at (520) 724-4330.
- Pima County has three 24/7 Ballot Drop Boxes where voters can drop off their ballot at any time, day or night
  - **DOWNTOWN WALK UP: Recorder's Office 240 N. Stone** – In the Courtyard facing the Recorder's Office.
  - **DOWNTOWN DRIVE UP: Recorder's Office, 240 N. Stone** – On the utility driveway between 240 N. Stone and 200 N. Stone.
  - **EAST SIDE DRIVE UP: Recorder's Office, 6920 E. Broadway Blvd.** – At the southwest corner of the parking lot in front of the Pima County Health Department office.
- Check [Pima.Vote](#) for up-to-date times, dates and locations for Early, Emergency or Election Day Voting.

### How do I know if I'm eligible to vote?

To be eligible to participate in the CD7 General Election, voters must:

- Reside in Congressional District 7 at least 29 days before the General Election
- Be a United States Citizen
- Be at least 18 on Election Day
- Have their rights restored if they have been convicted of a felony
- Not been adjudicated an incapacitated person
- Check your eligibility via our [Voter Dashboard](#) or by calling the Recorder's Office at (520) 724-4330.

## Important Dates

Last day to request and be mailed a ballot	Friday, September 12, 2025
Recommended last day to mail ballots back	Tuesday, September 16, 2025
Last day to vote early in person and drop off your ballot	Friday, September 19, 2025
Emergency Voting	Saturday, September 20 and Monday, September 22, 2025
<b>Election Day</b> – Vote Centers open 6 am – 7 pm*	Tuesday, September 23, 2025

\*On Election Day, you can vote at any Pima County Vote Center. Check [Pima.Vote](https://pima.vote) for locations.

## What else do I need to know?

- Ballots can be sent to a temporary location via the [Voter Dashboard](#) or by calling the Recorder's Office at (520) 724-4330.
- We have several [accessibility resources](#) to help any voters with disabilities, mobility concerns or language barriers. You can call (520) 724-4330 for assistance.
- Household members, family or caregivers are allowed to drop off ballots other than their own. Those ballots must be in a Ballot Affidavit Envelope signed by the voter.
- Ballots must be received by the Pima County Recorder's office by 7 p.m. on Election Day, Tuesday, September 23, 2025. [Proper identification is required](#) to be issued a ballot, but not to drop off.
- Sign up for text or email alerts to track your ballot and to receive alerts about changes you make to your voting record via the [Voter Dashboard](#).
